The group hosted three Youth Mental Health Awareness Convocations at local high schools, featuring nationally-known youth mental health speaker and author, Jeff Yalden.

A LEGACY OF LEADERSHIP Crystal Clover Gift Provides for Greatest Need

Today, a prospective 4-H'er may learn about the program through a website or social media. For Kevin Armstrong, that message came on the chalkboard of his elementary school in Daviess County.

"I saw a notice for a 4-H meeting and mentioned it to my dad, who happened to be a 10-year 4-H member in his youth," Kevin said. "He encouraged me to attend, and when I found out a lot of my friends were joining, I thought, 'why not?'"

Little did he know, that simple chalkboard message would launch his own 10-year 4-H experience – one that would forever shape his life.

"I'm incredibly grateful for the formative experience 4-H provided for me. I didn't recognize at the time that I was developing incredible leadership skills, lifelong friendships and personal interests that are still hobbies to this day," Kevin said.

One of Kevin's favorite programs was the 4-H public speaking competition. After excelling at the county level, he went on to win the state championship, and years later served as a judge. For Kevin, whose career has included leadership positions with the United Methodist Church, DePauw University, Methodist Health Foundation, and IU Health, that experience was invaluable.

"Practicing and competing not only helped me learn to speak well," Kevin said, "it instilled a passion for leadership storytelling which I still use and teach."

More than five decades after his time in 4-H, he has reunited with the organization that made a lasting impact on his life, joining the Board of Directors of the Indiana 4-H Foundation. Kevin also gives back to the organization through financial support.

"I give to the Foundation out of gratitude for the incredible experiences provided to me and my

peers," Kevin said. "When paired with the generosity of others who have had similar experiences, I know we can make a lasting impact."

Kevin chose to endow his Crystal Clover (an annual gift of \$1,000 or more) to the Dr. Robert Abel and Betty Abel Endowment for the Indiana 4-H Foundation, which is held and invested by the Purdue Research Foundation. The endowment provides annual revenue that the Foundation leadership team can use for its greatest needs.

"While I could have directed this gift to a specific program or county, I chose to allow the Foundation to utilize it for the greatest need. Whether that be creating new programming or keeping the lights on, it's all critical to providing opportunities for youth state-wide."

In doing so, Kevin has gifted a legacy of leadership for generations to come.

County Endowments Bring A New Season of Growth for 4-H

Eric Wolfe spent much of his childhood outside on his family's six-acre property in Clay County. The setting was an ideal place for Eric and his siblings to explore their interest in 4-H programs, which included gardening, raising animals, and other outdoor projects.

"Though my parents grew up in inner-city Indianapolis and didn't participate in 4-H, they encouraged us to have as many new experiences as possible," Eric said. "4-H turned out to be the perfect fit for me."

As a member of the 4-Ever Achievers Club in Staunton, Eric enjoyed raising chickens and ducks and had his first exposure to 4-H leadership as the club's President.

That would be the first of his many leadership roles at the local, state, and ultimately, national level. In 1999, Eric was selected as one of two Indiana Junior Leaders to represent the state at the National 4-H Conference in Washington, D.C. where he was elected as the National 4-H Youth Directions Council Executive Director. The position included a paid internship during which he traveled extensively to meet state and county leaders around the country.

Eric took full advantage of those opportunities and leveraged the skills he learned along the way to cultivate a successful career in real estate beginning in 2005, and

in 2017 founding Prime Real Estate Group in Greencastle, where he currently lives with his wife, June. He has remained connected to 4-H through the Indiana 4-H Foundation, joining the Board of Directors for a second time in 2020.

"Throughout my career I donated when I was able because I wanted to give back to the programs that had given so much to me," Eric said.

When the time was right, Eric and June decided they wanted to make a significant gift that would nurture the community in which they lived. "Because 4-H played such an influential role in my life, I knew that a large gift to Putnam County 4-H could provide a lasting impact for generations to come," he said.

Eric also knew there were many loyal 4-H alumni and others with meaningful connections to 4-H who felt similarly.

Planting the seeds of perennial giving, he began a community-wide fundraising campaign in Putnam County in 2021 to establish an endowment that would provide continuous, unrestricted income for the county 4-H program. Though the minimum amount needed to establish an endowment is \$25,000, Eric was determined to raise \$100,000 from multiple donors.

"This endowment campaign is the perfect example of the power of collective generosity. Every single gift is important, regardless of size," Eric said. Now valued at more than \$70,000, the Putnam County 4-H Endowment is the largest county endowment in the state – and growing.

Indiana 4-H Foundation Executive Director Shelly Bingle is eager to see similar endowments established for every county. She said, "This type of endowment provides ongoing income that county leaders can use to address their greatest needs as they arise, choosing what to grow in their 'garden' and when to harvest. It also empowers educators with the flexibility to offer the most relevant and impactful programming for their members."

As for Eric, he'll continue to forge ahead in pursuit of his \$100,000 goal for Putnam County. "I'm incredibly grateful to the founding donors who helped establish this endowment and to everyone that continues to help it grow. I know our efforts will create lasting opportunities for the future leaders of our county and state."

WHAT YOU NEED TO KNOW ABOUT ENDOWMENTS

\$25,000 is the minimum amount required to establish a county endowment with the Indiana 4-H Foundation.

An endowment of \$25,000 provides nearly \$1,000 in annual revenue for the county program to use for its greatest needs.

Currently, county endowments earn 3.9% interest on their principal. The Indiana 4-H Foundation does not charge a fee to administer the endowment; therefore the county receives the full amount of interest as income.

County endowments can be established by a single or multiple donors. Gifts to the endowment can be made as one-time or multi-year cash gifts or through estate gifts.
